

# Statement on EU REACH Regulation 1907/2006

This statement reflects Senseair's understanding of the EU REGULATION (EC) No 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (EU REACH). It outlines the various obligations applicable to Senseair's products and the requirements regarding articles. Specifically, EU REACH requires us:

- To inform recipients if an article placed on the European market contains a Substance of Very High Concern (SVHC) in excess of 0.1% by weight. SVHCs are identified in the [Candidate List of substances of very high concern for Authorisation](#) – ECHA (europa.eu);
- To provide necessary information corresponding to Article 33 to allow for safe use if the article contains SVHC:s in excess of 0.1% by weight;
- To submit information to the database with information on substances of concern in articles, as such or in complex objects (products), "SCIP", created due to the revision of the Waste Framework Directive (2008/98/EC) if the article contains SVHC:s in excess of 0.1% by weight;
- To notify ECHA if an article contains an SVHC in excess of 0.1% by weight and the total amount of the SVHC present in all articles produced or imported to the European market exceed one metric ton per year;
- To cease shipment of articles containing EU REACH Annex XIV Substances Subject to Authorisation unless authorisation has been obtained; and,
- To cease shipment of articles containing EU REACH Annex XVII Substances when restrictions apply.

Having evaluated supplier certifications and material composition declarations, as well as Senseair's specifications, Senseair has, to the best of our knowledge and belief, determined that:

- Except as noted in the latest version of the Senseair Reach SVHC Declaration List (*Senseair Reach SVHC Declaration List*, version 2025-06-25), Senseair products do not contain the substances within the **250** entries currently on the SVHC Candidate List in excess of 0.1% by weight per article as published by ECHA with latest publication date **June 25, 2025**;
- In cases where SVHC substances are present in Senseair products the identity and the location of the substance constitutes necessary information for safe use;
- In cases where SVHC substances are present in Senseair products the information has been submitted to the SCIP Database and the SCIP Part Number is entered in the latest version of the Senseair Reach SVHC Declaration List (*Senseair Reach SVHC Declaration List*, version 2025-06-25);
- The weight of the SVHC candidate substances contained in Senseair products shipped into the EU has not exceeded one metric ton per year and annual reporting to ECHA is not required;
- Senseair products do not contain any of the substances within the **59** entries subjected to authorisation under the EU REACH Annex XIV as published by the European Union with latest publication date **June 23, 2025**;
- Senseair products do not contain any of the substances above the maximum limits under the given application in Annex XVII of the EU REACH Regulation.
